VALID SURVEILLANCE APPROVED & INSURED VEHICLE:

- > Preferred: Minivan or van, sport utility vehicle, or truck with extended cab (full-size or mini okay).
- > Required: Car
- > Neutral color and body style. No custom paint schemes allowed.
- > Keep and maintain vehicle insurance.

CAMCORDER AND DIGITAL RECORDER EQUIPMENT.

Other equipment as needed; assistance available from Interstate Reporting Co., Inc.

TRAVEL REQUIRED:

Approximately 20-30% overnight/hotel stays.

- Must be willing to travel throughout the state of Wisconsin, and/or any other state IRC is licensed in.
- One day you may be in Stevens Point, and the next day in Milwaukee.
- All cases either start or end from IRC office, hotel, or your home depending on case instructions.

FULLY FUNCTIONAL CELLPHONE REQUIRED.

KEY RESPONSIBILITIES:

- Conduct stationary and mobile surveillance of subjects as assigned.
- Document findings using high-quality video and/or photography, using cameras, camcorders, specialty, and cellphone devices.
- > Prepare clear, concise, and detailed written reports of observations.
- Maintain accurate and organized case files and evidence logs/form. Operate covert recording equipment and surveillance vehicles.
- > Testify in court or depositions when required.
- > Communicate regularly with the Investigations Director and provide timely updates.
- Adhere to all local, state, and federal laws during investigations.
- Always maintain confidentiality and professionalism.

REQUIREMENTS:

- ➤ Private Detective License | Pass Background Check
- ➤ High school diploma or GED required; associate or bachelor's degree preferred.
- > Valid driver's license and clean driving record.
- Willingness to travel and work irregular hours, including early morning, evenings, weekends, and holidays.
- > Strong observational, analytical, and writing skills,
- > Ability to work independently with minimal supervision.
- Proficiency in using video and photography equipment, computer software (Microsoft Office), and case management tools.

PREFERRED QUALIFICATIONS:

- ➤ Prior experience in surveillance, law enforcement, military, or investigations.
- > Experience in insurance fraud or workers' compensation investigations.
- ➤ Bilingual skills.

PHYSICAL REQUIREMENTS:

- ➤ Must be able to sit in a vehicle for extended periods of time (up to 8+ hours).
- Ability to drive long distances, often across multiple days or assignments.
- Must be able to remain stationary or concealed for prolonged periods during surveillance.
- Occasional lifting and carrying of equipment (up to 25 lbs.).
- Ability to walk, climb stairs, or pursue subjects discreetly in various environments (urban, rural, indoor/outdoor).
- Must have good visual acuity (with or without corrective lenses) for video surveillance and documentation.
- Tolerance for varied weather conditions (heat, cold, rain) during outdoor surveillance.
- Must maintain alertness and concentration for long durations, including irregular hours, nights, weekends, and holidays.



Please examine closely your personality and lifestyle.
